In the absence of the Chairman, Cllr Nicholls chaired the meeting as agreed by all members present and welcomes everyone to the meeting

3. **Approval of minutes** for 10th May 2022

4. **Finance** – All documents circulated before and during the meeting
Balance of account £34306.10 @15.6.2022 approved and bank statements signed.
Receipt CIL funds received £651.22 on 17.5.2022 – noted.
Payments approved for Clerks expense £33.50
The clerk reported that an overpayment of salary was made in May for £21.73 and an underpayment made in June of £21.73 to compensate for this.
Members acknowledged St Andrews School's thanks to the PC for their new bench.

 - b. RE: Wildlife and Countryside Act 1981 - S53 Application - For adding a bridleway in the Parish of Clifton Campville, route known as Twizles Lane from SK22980993 to SK23451075 - STA-0433. file ref: 023843DW. **Observation made was that the PC cannot contribute to this application**
 - c. 22/00931/COU - (Change of Use) Applicant: Mr Edward Leedham. Location: The Bandlands, o Mans Heath Road, Clifton Campville, Tamworth. Proposal: Change of use of land to form menage and erection of stable block.
