

CLIFTON CAMPVILLE WITH THORPE CONSTANTINE PARISH COUNCIL

MINUTES OF MEETING HELD ON 14th September 2021 @ 7.30pm
In the Clifton Campville village hall.

1. Apologies – Cllr C Bent (chairman) Cllr S Bent. Cllr Lamb. Cllr Amsden.

Cllr Nicholls took the role of Vice Chair for this meeting and this was agreed by all members present.

2. Declaration of interest - None

3. Members of the public questions:

Members were concerned that a sewage surcharge had occurred to manholes in the gardens of 2 properties that appeared to be associated with the recurring surface water flooding on Main Street". The affected residents will be encouraged to highlight these specific concerns direct with Severn-Trent. The Clerk has also been in touch with ST and will email further comments of public to them.

4. Minutes of previous meeting 20th July 2021

These were circulated prior to the meeting, taken as read and signed as a true record. A copy of the minutes will displayed on to the web site.

5. Matters arising from minutes

- a. Plant boxes by notice board - Cllr Nicholls presented 2 quotes for the replacement planters for the Council Notice Board in Clifton, from a supplier who's work has been installed, and commended, in existing locations in the Parish. Members approved £200 quote from WoodPecker SAS.

- b. Bromford Donation – Members informed that payment has still not been received but is being addressed.

6. Finance

7. Dog guidance/path usage sign - Rules of pathways not being adhered to. Clerk informed members that signs can be requested by landowner i.e 'Keep dogs on a lead', 'Use designated pathways' etc. Members agreed to postings on social media and website of 'Follow the Countryside Code' and 'Rights of Way' rules and guidance.

8. Highways – Road repairs in Syerscote Lane have been reported as inadequate. The Clerk is already in touch with The Highways Dept about this and further photographic evidence was presented at the meeting. These will be forwarded to Highways Dept and a request was also made to copy in Cllr A White on the situation.
